Annually, the USTA National Junior Tournament Schedule has four (4) Level 1 Championships that use Section Quota as a factor within the player acceptance process. Section Quota Lists will be published monthly on the <u>USTA Ranking Page</u>.

The criteria for inclusion on the lists and method of calculating the lists shall be the same criteria used for National Standings Lists (See Regulation IV.C. Comment), except:

- 1. Players must meet the requirements of USTA Regulation IX.C.1.
- 2. Only those players who are residents of the Sectional Association may appear on each Sectional Quota List.
- 3. The following results will be included:

a player's best 6 singles results and best 6 doubles and/or mixed doubles results may include no more than 2 singles results and 2 doubles and/or mixed doubles results, respectively, that are from tournaments sanctioned by a body other than the Sectional Association or one of its District Associations, except that an Intersectional Team Tournament and the USTA Battle of the Sections shall be considered as though sanctioned by each Sectional Association participating in the tournament.

- 4. A Sectional Association may adopt a wild card or waiver process to place up to two players on the Sectional Quota List and within the quota assigned to the Sectional Association for the USTA National Championship.
- 5. A Sectional Association may not impose a requirement that a player participate in a specific tournament in order to appear on a Sectional Quota List.

### Sectional Quota FAQs

#### How is the number of Section Quota Spots in a Level 1 draw calculated?

Each Sectional Association is guaranteed a minimum number of players who may be accepted into certain Level 1 Championships. The number of Section Quota spots in the draw is determined by a ratio that combines the number of Unique Registrations at the end of each year in Level 3 Closed-Level 7 events and players from each Section who are in the top 150 from the Year End Rankings. It is important to note that quota numbers adjust each and every year because of this ratio calculation. **2025 Section Quota Numbers will be available soon**.

#### How do I view the Section Quota Lists?

Each Section's Quota list will be published monthly as indicated in the Table above and can be viewed on the <u>USTA Rankings Page</u> - Select "Sectional Quota List" on the "Ranking List" drop down. Also, your position on your Section's Quota list is displayed in your USTA Profile.
